## EXPORT LIST UPDATE

**Upon request by the Idaho Department of Insurance**, the SLA board and Export List Task Force submitted proposed E.L. class additions and deletions. Not all the task force recommendations were adopted but we will have the opportunity to revisit next year. Director Cameron has issued a Notice of Intent to Adopt which allows for written comment on or before July 19, 2021, from any interested party in support or opposition. # IDAHO LAW Effective July 1, 2021

The Idaho Department of Insurance has updated Title 41, Producer Licensing Chapter 10 by repealing section 1027. Licensed Producers and Surplus Lines Brokers will not be required to return their license, upon expiration of same, to the director of insurance.

The Idaho Department of Insurance has updated Title 41-1233 Independently Procured by rescinding section 4 to eliminate 6% interest on delinquent tax.
